The Village of Orland Park, Illinois ("VILLAGE") and MEADE, INC. ("CONTRACTOR")

WHEREAS, on February 1, 2020, a certain Agreement regarding Traffic Signal Maintenance between the Village and the Contractor was executed (hereinafter referred to as the "Agreement"); and,

WHEREAS, on December 23, 2020, a certain Agreement regarding Traffic Signal Maintenance between the Village and the Contractor was amended (hereinafter referred to as the "Addendum No. 1"); and

WHEREAS, on December 20, 2021, a certain Agreement regarding Traffic Signal Maintenance between the Village and the Contractor was amended (hereinafter referred to as the "Addendum No. 2"); and

WHEREAS, on November 21, 2022, a certain Agreement regarding Traffic Signal Maintenance between the Village and the Contractor was amended (hereinafter referred to as the "Addendum No. 3"); and

WHEREAS, on November 20, 2023, a certain Agreement regarding Traffic Signal Maintenance between the Village and the Contractor was amended (hereinafter referred to as the "Addendum No. 4"); and

WHEREAS, on December 16, 2024, a certain Agreement regarding Traffic Signal Maintenance between the Village and the Contractor was amended (hereinafter referred to as the "Addendum No. 5"); and

WHEREAS, on November 17, 2025, a certain Agreement regarding Traffic Signal Maintenance between the Village and the Contractor was amended (hereinafter referred to as the "Addendum No. 6"); and

WHEREAS, the Village wishes to modify the CONTRACT DOCUMENTS, WORK TO BE PERFORMED, TIME OF PERFORMANCE, and PRICING FOR MATERIALS AND SERVICES.

NOW, THEREFORE, for and in consideration of the foregoing and the mutual covenants herein contained, it is agreed by and between the parties hereto as follows:

Between
The Village of Orland Park, Illinois ("VILLAGE") and MEADE, INC. ("CONTRACTOR")

1. In the event of any conflict or inconsistency between the provisions of this Addendum 6 and the Agreement, the provisions of this Addendum 6 shall control.
2. **THE CONTRACT DOCUMENTS** of said Agreement shall be amended to include Addendum 6 dated December 1, 2025, and "Contract Customers Labor & Equipment Rates on Time and Material Work – June 1, 2025, through May 31, 2026."
3. **SECTION 1: WORK TO BE PERFORMED** of said Agreement shall be amended to add Traffic Signal Cable Locating Services for 2026.
4. **SECTION 2: TIME OF PERFORMANCE** of said Agreement shall be amended to read as follows:

The term for this Agreement shall be for a period of one (1) year from January 1, 2026, to December 31, 2026, with an option to renew for a one (1) year term.

5. **SECTION 4: PRICING FOR MATERIALS AND SERVICES** in said Agreement shall be modified to reflect an increase of 3.1% to the existing rate, for a new monthly rate of \$207.05 per location per month per Traffic Signal location, effective January 1, 2026. In addition, the following provisions shall be added to Section 4:

"Pricing for non-routine extra work: Pricing for non-routine extra work shall be as agreed by and between the parties and shall be directed by the Director of Public Works on an as-needed basis, up to a total of \$30,000 of work, subject to the terms and conditions outlined herein.

Pricing for traffic signal cable locates: Pricing for traffic signal cable locates shall be as agreed by and between the parties based on the "Contract Customers Labor & Equipment Rates on Time and Material Work – June 1, 2025, through May 31, 2026," up to a total of \$7,500.00 of work, subject to the terms and conditions outlined herein."

The total not to exceed contract price for FY 2026 is \$69,799.80.

7. This Addendum 6 may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.

This Addendum 6, made and entered into effective the **1st day of December, 2025**, shall be attached to and form a part of the Agreement dated the 1st day of February, 2020, amended December 23, 2020; December 20, 2021; November 21, 2022; November 20, 2023; and December 16, 2024, and shall take effect upon signature below by duly authorized agents of both parties.
