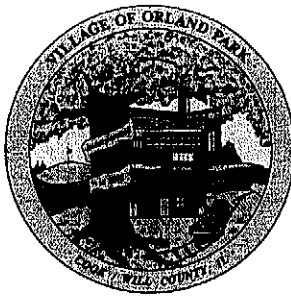

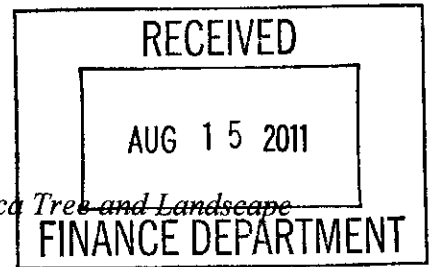

**ADDENDUM to**  
*Tree Replacement Program Contract*

**Dated**  
February 7, 2011

**Between**  
*The Village of Orland Park, Illinois ("VILLAGE") and Mid-America Tree and Landscape ("CONTRACTOR")*



RE: To extend the Tree Replacement Program for 2011-13 to include parkway trees replaced by Public Works

1. In the event of any conflict or inconsistency between the provisions of this Addendum and the Agreement, the provisions of this Addendum shall control.
2. In **SECTION 2: GOODS TO BE PURCHASED, COST AND DELIVERY, SCOPE OF THE WORK AND PAYMENT:**, of said Agreement, the sentence "*Tree Purchase and Planting – 3" caliber trees to be planted in the parks and or on Village properties for the Village of Orland Park.*" shall be stricken and replaced with the following sentence "*Tree Purchase and Planting – 3" caliber trees to be planted in the parks, on Village properties, and or on parkways for the Village of Orland Park.*"
3. All of the other terms, covenants, representations and conditions of said Agreement, not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.
4. This Addendum may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.

This Addendum, made and entered into effective the **5th day of August, 2011**, shall be attached to and form a part of the Agreement dated the 7<sup>th</sup> day of February, 2011 and shall take effect upon signature below by duly authorized agents of both parties.
