hereby amends the original Professional Services Agreement dated August 26, 2011 as follows:

The CLIENT and COMPANY agree to amend the Scope of Services of the original Professional Services Agreement and previous amendments to include the following:

- Traffic Counts – 12 Hour Manual Traffic Counts
  - Per conversations with Mr. Jason Salley - IDOT Geometrics, the existing traffic counts at the intersection of US 45 and 156<sup>th</sup> Street from 2004 are no longer relevant. New counts at the intersection must be conducted in order to determine existing traffic numbers and current peak hours.
  - Coordinate new traffic counts with sub-consultant. Determine 2012 AM & PM Peak Hours, project traffic to 2040 design year and revise IDS traffic tables.
  - Additional work: 4 hours, \$450.00 + \$1,200.00 Traffic Counts
- Total Amount for Additional Services: 4 hours + Traffic Counts, \$1,650.00

In consideration for these services, the CLIENT AGREES to adjust the payment for services performed by COMPANY on the following basis:


- Per current rate schedule with a maximum fee to be increased by One thousand, Six hundred Fifty Dollars (\$1,650.00)
