



**ADDENDUM A TO RENTAL & SERVICE OF PORTABLE TOILETS, DATED MARCH 17, 2025,
BETWEEN
THE VILLAGE OF ORLAND PARK AND SERVICE SANITATION, INC.**

WHEREAS, on March 17, 2025, a certain Agreement between the VILLAGE OF ORLAND PARK (hereinafter referred to as “Village”) and Service Sanitation, Inc (hereinafter referred to as “Consultant”) for the performance of certain professional services for the Village in connection with Rental & Service of Portable Toilets (hereinafter referred to as the “Project”, the “Work”, or the “Services”) was executed (hereinafter referred to as the "Agreement"); and,

WHEREAS, the Village wishes to modify **SCOPE OF WORK, COMPENSATION, AND CONTRACT DOCUMENTS**,

NOW, THEREFORE, for and in consideration of the foregoing and the mutual covenants herein contained, it is agreed by and between the parties hereto as follows:

1. In the event of any conflict or inconsistency between the provisions of this Addendum A and the Agreement, the provisions of this Addendum A shall control.
2. **SECTION 1: SCOPE OF THE WORK** of said Agreement shall be amended to include the “Scope of Work” as set forth in Consultant’s Proposal, dated April 20, 2026, for the rental and servicing of ADA-compliant restroom trailer units at Centennial Park West, which include running water and temperature control and enhance public accessibility to events at CPW.
3. **SECTION 2A: COMPENSATION** in said Agreement shall be amended to add the words strike “Total Not-to-exceed amount of \$308,245.70” and replace with a new “Total not-to-exceed amount of \$360,515.34”. Contract was increased by \$52,269.64.
4. **SECTION 3: THE CONTRACT DOCUMENTS** of said Agreement shall be amended to include Addendum A, dated May 4, 2026: and “Proposal for Work, dated April 20, 2026”.
5. All of the other terms, covenants, representations and conditions of said Agreement not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.
6. This Addendum A may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.

This Addendum A, made and entered into effective the 4th day of May, 2026, shall be attached to and form a part of the Agreement dated the 17th day of March, 2026, and shall take effect upon signature below by duly authorized agents of both parties.

IN WITNESS WHEREOF, the parties have caused this Addendum A to be executed by their duly authorized officer in quadruplicate counterparts, each of which shall be considered as an original.
