

**Village of Orland Park**  
**Surplus Equipment Online Public Auction Affidavit**

**Section A: Definitions**

"Employee of the Village of Orland Park" means an individual employed by the Village of Orland Park, whether part-time or full-time, but excludes elected officials and Village contractors.

"Person" means any individual, entity, corporation, partnership, firm, association, union, trust, estate, as well as any parent or subsidiary of any of the foregoing, whether or not operated for profit.

"Relative" means a person who is related to the person completing this document as spouse or domestic partner, or as any of the following, whether by blood or by adoption: parent, child, brother or sister, aunt or uncle, niece or nephew, grandparent, grandchild, father-in-law, mother-in-law, son-in-law, daughter-in-law, sister-in-law, brother-in-law, stepfather or stepmother, stepson or stepdaughter, stepbrother or stepsister, half-brother or half-sister.

"Interest in any firm" means any ownership or beneficial interest in any firm, whether direct or indirect, and any other financial or economic interest in any hired trucks or equipment doing business with the Village of Orland Park.

6. I understand that some or all of the information provided in this document may be made available to the public on the Internet, in response to a Freedom of Information Act request, or otherwise. By completing and signing this document, I waive and release any possible rights or claims which I may have against the Village in connection with the public release of information contained in this document and also authorize the Village to verify the accuracy of any information submitted in this document.
7. I understand that by signing this document my signature will be kept on file and may be compared with Village of Orland Park equipment reports, inventory or other documents.
