Seven years ago, I wanted to replace it with vinyl siding because the aluminum gets scratched, and they said no. It's all white except for the roof and the roof will be the same color. (refer to audio)

Commissioner Nugent asked he was going with gray for the roof. (refer to audio)

Mr. Shutay stated when I bought the property the roof was green.

Commissioner Nugent responded I'm talking about the siding.

Mr. Shutay replied the siding has always been the same color.

Development Services Assistant Director Carrie Haberstich added they're just doing the roof.

Mr. Shutay stated we're not changing the siding.

Commissioner Nugent asked if the petition called it gray.

Ms. Gorman added it's just a re-roof.

Commissioner Nugent responded I see roof remains gray.

Chairman Parisi stated I didn't see that.

Commissioner Nugent asked if the house will stay white.

Mr. Shutay responded yes, correct. Everything will be the same.

Commissioner Nugent asked if the former schoolhouse was wood.

Mr. Shutay responded that's all-wood siding. I'm going to keep it the way it is
