ADDENDUM A to
Sidewalk Replacement 2017

Between

The Village of Orland Park, Illinois ("VILLAGE") and Davis Concrete Construction Co. ("CONTRACTOR")

WHEREAS, on June 22, 2017, a certain Agreement regarding Sidewalk Replacement 2017 between the Village and the Contractor was executed (hereinafter referred to as the "Agreement"); and,

WHEREAS, the Village wishes to modify the SCOPE OF WORK.

NOW, THEREFORE, for and in consideration of the foregoing and the mutual covenants herein contained, it is agreed by and between the parties hereto as follows:

1. In the event of any conflict or inconsistency between the provisions of this Addendum and the Agreement, the provisions of this Addendum shall control.
2. **SECTION 1: THE CONTRACT DOCUMENTS** of said Agreement shall be amended to include "Addendum A dated September 14, 2017", "Proposal dated August 23, 2017 Village Center Sidewalks" and "Sidewalk Plans"
3. **SECTION 2: SCOPE OF THE WORK AND PAYMENT** of said Agreement shall be amended to include the following before the words "(hereinafter referred...)":

Install pedestrian walks throughout the green space at the Village Hall Complex, 14700 S. Ravinia Ave., Orland Park, IL per the proposal dated August 23, 2017 at a cost of \$5.85/s.f. plus reinforcement and detectable warnings for a total cost of Forty Two Thousand Thirty-Six and 50/100 (\$42,036.50) Dollars

4. All of the other terms, covenants, representations and conditions of said Agreement not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.
5. This Addendum may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.

This Addendum, made and entered into effective the **14 day of September, 2017**, shall be attached to and form a part of the Agreement dated the 22 day of June, 2017 and shall take effect upon signature below by duly authorized agents of both parties.


