2011-0464 HVAC Repairs for Sportsplex and Cultural Center

Park's Division Director Frank Stec reported that within the past two weeks the Village lost two HVAC compressors; one at the Sportsplex and one at the Cultural Center. Neither unit was budgeted to be replaced and will need a budget adjustment. Both units were repaired by Building Maintenance personnel. Cost breakdown as follows:

Sportsplex - \$6,994.97 with core exchange -Thermosystems Parts Division, Sportsplex - \$720.00 for crane rental/ hoist compressor set and compressor down--Stevenson Crane Service Inc.

Cultural Center - \$9,622.83 with core exchange -Temperature Equipment Corp.
