ITEMS FOR SEPARATE ACTION**2010-0167 Traffic Discussion on 145th Street**

Chairman Brad S. O'Halloran introduced Mrs. Kanagy an Orland Park Resident who would like to discuss speeding vehicles on 145th Street.

Orland Park Resident Mrs. Kanagy who lives at 9890 West 145th Street. Mrs. Kanagy expressed concerns of speeding vehicles on 145th Street and discussed the traffic study of September 2009, cut through traffic caused by trains blocking West Avenue, volume of traffic and various traffic devices.

Police Chief Timothy McCarthy reported that Lt. Bianchi has been working closely with Mrs. Kanagy with both the radar guns and smart trailers. The September 2009 study found the average speed to be 18 miles an hour and the 85th percentile at 23 miles an hour. The highest speed recorded was 44 miles an hour which is double the speed limit. The total number of westbound vehicles were 2,366 during a 16 day period of time. The eastbound computer malfunctioned.

Chief McCarthy reported there being no records on any crashes in that area. People do run the stop signs and we do run traffic details in and around that area.

Trustee O'Halloran recommended the matter be reviewed by the Parking and Traffic Advisory Board for an additional study and action.

2010-0195 Disposal of Certain Seized Vehicles at Public Auction Ordinance

The police department requests that the Village declare two (2) forfeited vehicles being processed for titles in the name of the Village of Orland Park and one (1) impounded vehicle with a certificate of purchase in the name of the Village of Orland Park described herein as excess property and to dispose of at public auction. The vehicles were seized by the department and forfeited to the village by the Circuit Court of Cook County from drivers who were driving their vehicle while their licenses were suspended for DUI.

Chief McCarthy reported that in applying Title 7, section 7-4-23; Staff discovered that the language of this section that the "licensee should suffer any loud or boisterous talking" is vague, confusing and by definition may in fact be simply wrong. We request that the word 'suffer" be removed and changed to "allow" to clarify this section.

2010-0197 Amendment to the Massage Establishment Ordinance

Chief McCarthy reported that approximately three years ago, state law was amended whereby massage therapists were required to be licensed by the State of Illinois. Prior to that time; massage therapists were licensed by the Village of Orland Park after a background investigation was conducted on them by the Orland Park Police Department. The Village of Orland Park may still regulate the massage therapy businesses.

The changes in this Ordinance reflect the elimination of the Village's requirement to license and do backgrounds on massage therapists and minor changes to the regulations of massage therapy businesses.

I move to recommend to the Village Board to pass an Ordinance entitled: AN ORDINANCE AMENDING TITLE 7, CHAPTER 14 OF THE ORLAND PARK VILLAGE CODE - MASSAGE ESTABLISHMENTS
