



**ADDENDUM B TO 2024 CHC WELLBEING – ON-SITE WELLBEING SCREENING, DATED  
AUGUST 12, 2024, AMENDED NOVEMBER 18, 2024,  
BETWEEN  
THE VILLAGE OF ORLAND PARK AND CHC WELLNESS, INC., DBA CHC WELLBEING, INC.**

WHEREAS, August 12, 2024, a certain Agreement between the VILLAGE OF ORLAND PARK (hereinafter referred to as “Village”) and CHC Wellness, Inc., DBA CHC Wellbeing, Inc. (hereinafter referred to as “Consultant”) for the performance of certain professional services for the Village in connection with 2024 CHC Wellbeing - On-site Wellbeing Screening (hereinafter referred to as the “Project”, the “Work”, or the “Services”) was executed (hereinafter referred to as the "Agreement"); and,

WHEREAS, on November 18, 2024, a certain Agreement between the Village and the Consultant for the Services was previously amended (hereinafter referred to as the "Addendum A"); and

WHEREAS, the Village wishes to modify COMPENSATION, CONTRACT DOCUMENTS, and TERM OF THE CONTRACT.

NOW, THEREFORE, for and in consideration of the foregoing and the mutual covenants herein contained, it is agreed by and between the parties hereto as follows:

1. In the event of any conflict or inconsistency between the provisions of this Addendum B and the Agreement, the provisions of this Addendum B shall control.
2. **COMPENSATION** in said Agreement shall be amended to strike “A total amount of \$34,495.00”; and replace with a new “not-to-exceed contract amount of \$77,495.00.” The contract was increased by \$43,000.00 for the 2025 employee wellness screenings scheduled for July 8, 2025, and July 29, 2025, as well as a remote screening option.
3. **ARTICLE IV: EXTENT OF AGREEMENT - THE CONTRACT DOCUMENTS** of said Agreement shall be amended to include Addendum B, dated July 10, 2025.
4. **ARTICLE III (A.): TERM OF THE CONTRACT** of said Agreement shall be amended to strike the contract termination date, August 11, 2025, and replace with a revised contract termination date of September 11, 2025.
5. All of the other terms, covenants, representations and conditions of said Agreement not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.
6. This Addendum B may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.

This Addendum B made and entered into effective the **10<sup>th</sup>, day of July, 2025**, shall be attached to and form a part of the Agreement dated the 12<sup>th</sup>, day of August, 2024, amended November 18, 2024, and shall take effect upon signature below by duly authorized agents of both parties.

IN WITNESS WHEREOF, the parties have caused this Addendum B to be executed by their duly authorized officer in quadruplicate counterparts, each of which shall be considered as an original.
