



AN ORDINANCE ANNEXING PROPERTY (SURROUNDED TERRITORY - 10700 W. 159TH STREET)

BE IT ORDAINED by the President and Board of Trustees of the Village of Orland Park, Cook and Will Counties, Illinois:

SECTION 1

That this President and Board of Trustees find as follows:

- (a) The territory described in Section 2 of this Ordinance contains less than sixty (60) acres and is wholly bounded by the Village of Orland Park.
- (b) Such territory is not within the corporate limits of any municipality, but is contiguous to the Village of Orland Park, Cook and Will Counties, Illinois, a municipality existing under the laws of the State of Illinois.
- (c) The Village of Orland Park, Cook and Will Counties, Illinois, does not provide fire protection service, and the territory herein described is not located in a public library district.
- (d) Notice that the corporate authorities of the Village of Orland Park are contemplating the annexation of such territory has been published not less than ten (10) days prior to passage of this Ordinance, and, not less than fifteen (15) days before passage of this Ordinance, has been served by certified mail on the taxpayers of record of the proposed annexed territory described below, all as required by Section 7-1-13 of the Illinois Municipal Code (65 ILCS 5/7-1-13).

SECTION 2

That the territory legally described as follows:

THE SOUTH 455 FEET OF THE SOUTH HALF OF THE SOUTHEAST QUARTER OF SECTION 17, TOWNSHIP 36 NORTH, RANGE 12, EAST OF THE THIRD PRINCIPAL MERIDIAN, LYING WESTERLY OF THE WESTERLY RIGHT-OF-WAY LINE OF THE WABASH, ST. LOUIS AND PACIFIC RAILROAD EXCEPT THE WEST 870 FEET AND EXCEPT THAT PART DEDICATED FOR STREET IN COOK COUNTY, ILLINOIS.

That this Ordinance shall be in full force and effect from and after its passage and approval as required by law.
