Village Manager Grimes stated the Mayor and himself have met informally with the collective bargaining units. In order to report to the Board on those discussions, we must recess into Executive Session.

President McLaughlin stated that he has reevaluated the Officials budget. For several years a dinner was given in honor of the Commission and Advisory Board members as a thank you for the time that they volunteer. It was decided this dinner would be canceled for 2010.

President McLaughlin requested to go into executive session at this time.
