## **THE FOLLOWING PERTAINS TO OUR PROPOSAL:**

- 1. Furnish and install (1) 160kva 480v APC UPS system in basement.
- 2. Furnish and install (2) APC UPS battery cabinets.
- 3. Furnish and install approximately 50' of 3"conduit with 250mcm cable from main switchboard to UPS.
- 4. Furnish and install approximately 40' of 3"conduit with 250mcm cable from main switchboard to 115kva transformer.
- 5. Furnish and install 100' of 3/0 ground cable.
- 6. All conduit and boxes to be surface-mounted.
- 7. Provide two years of parts and labor warranty including batteries.
- 8. Provide load bank testing and manufacture start up with training.
- 9. Elevator will be required for delivery of UPS into basement. Max elevator load will be 1500 pounds.
- 10. Work due to unforeseen conditions not included.
- 11. All work performed during normal working hours.
