THE NORTH FIVE FEET OF LOT 8**





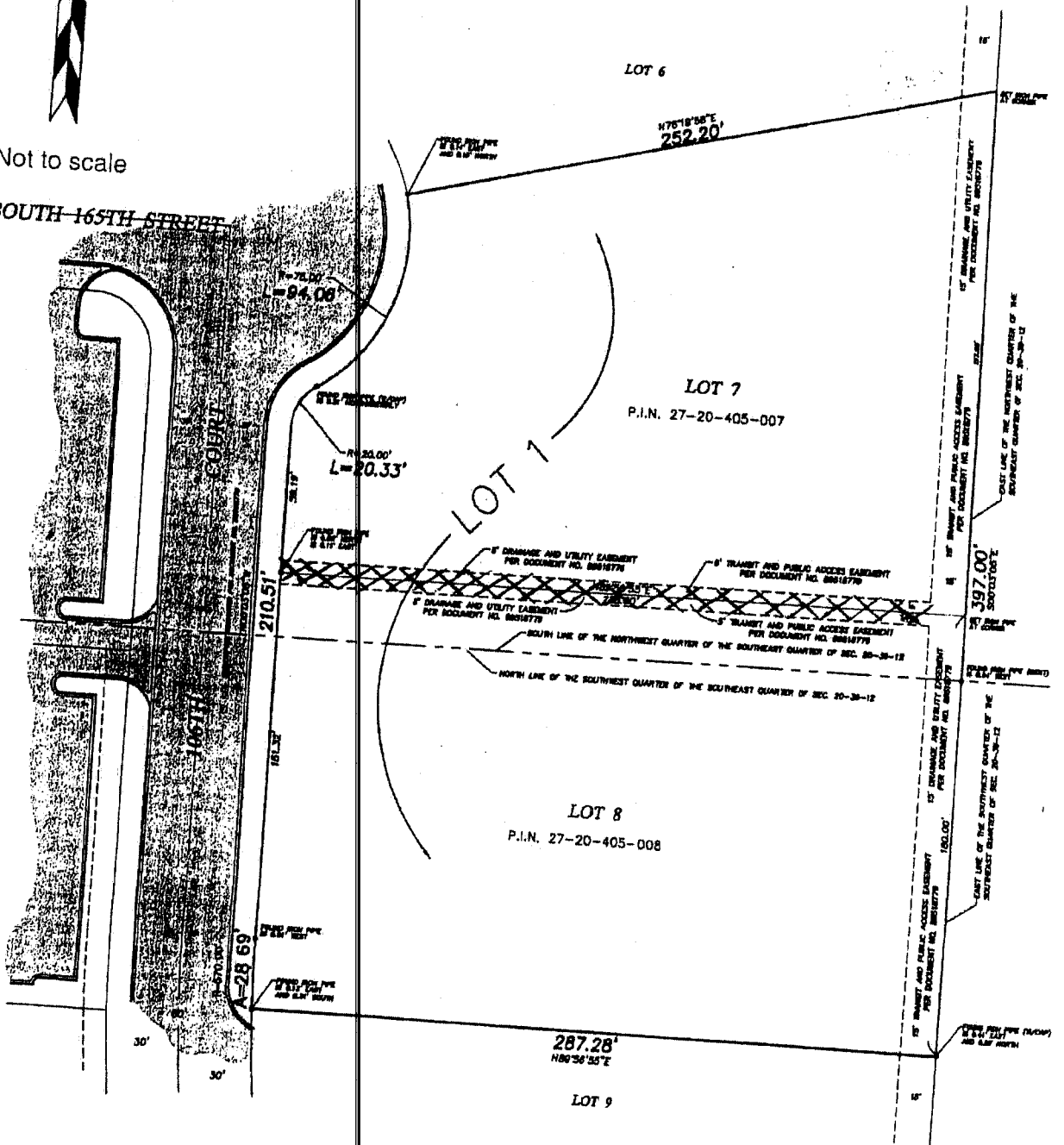
