**FOLLOWING PERTAINS TO OUR PROPOSAL**

1. Demo existing 600A /480V fused service switch.
2. Demo existing panels, transformer, sub panels, troughs, conduits and ball field controls equipment.
3. Identify existing circuits for building equipment systems, concession stand and washrooms.
4. Provide coordination with Com Ed for service shut down for main fused service section replacement.
5. Provide temporary power for building during shut down.
6. Relocate Com Ed meter to new location on exterior wall.
7. Furnish and install new 600A section with four 200A breakers.
8. Furnish and install (1) 75 KVA transformer to be hung from ceiling
9. Furnish and install transformer support.
10. Furnish and install (1) 200A/120/208V 60 circuit panel.
11. Rework existing conduits and circuits for building equipment systems, concession stand and washrooms into new panelboards.
12. Furnish and install new (2) 200A/480V 42 circuit panels.
13. Provide coordination with Musco for new control cabinets and poles.
14. Furnish and install new conduit and wire to Musco cabinets.
15. Furnish and install 480 volt branch circuits for new Musco control cabinets.
16. Furnish and install wiring to (5) 120V circuits for security cameras.
17. Furnish and install outlets on (5) poles for security cameras, conduit supplied by Musco.
18. All work performed during normal working hours.
19. Work due to concealed conditions and unforeseen ground not included.
20. Permit, bonds, license or special fees not included.
