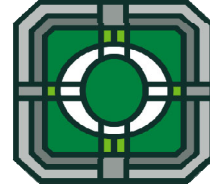


Village of Orland Park

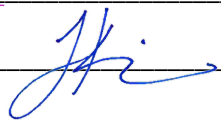
