THE FOLLOWING PERTAINS TO OUR PROPOSAL:

- 1. Furnish and install 40' of parallel 2 ½ conduits and from switchboard to transfer switch.
- 2. Furnish and install 240' of 4/0 wire from switch board to transfer switch.
- 3. Furnish and install (1) 400 amp 3 phase service rated transfer switch.
- 4. Furnish and install 50' of 2 ½ rigid conduit from transfer switch in basement to pin and sleeve connector on East outside wall.
- 5. Furnish and install 320' of 4/0 wire from transfer switch in basement to pin and sleeve connector on East outside wall.
- 6. Furnish and install (1) 200 amp 3 phase service rated pin and sleeve connection on East outside wall.
- 7. Furnish (2) 3" exterior wall cores.
- 8. All conduit and boxes to be surface-mounted.
- 9. All work performed during normal working hours.
