Note: The pricing offered is for the bare pump which is compatible for use with your existing guide rail and base elbow system using the existing pumps moveable fitting which bolts to the pump discharge flange and mates to the base elbow.

On any additional days or trips required to complete startup, resulting from non-Gasvoda & Associates Inc. supplied equipment being non-functional or any additional time spent as a result of the Purchaser's failure to comply with the above, shall be charged to the Purchaser at the current demand service rate.
