Police Chief Timothy McCarthy reported the Police Department budgeted for two replacement Tasers in the 2013 budget however five of our Tasers have malfunctioned beyond repair already this year.

The Police Department is requesting to purchase five replacement Tasers at a cost not to exceed \$7,076.40 which includes a rebate of \$135.00 for each Taser we return to the company.

On June 17, 2013, this item was reviewed by the Public Safety Committee, recommended for approval and referred to the Village Board of Trustees for consideration.
