#### GHA'S APPROACH:


With decades experience with hardscape condition assessment and analysis projects, GHA is uniquely positioned to complete this project efficiently while providing transparency to Village staff.

As the Village's GIS consultant, GHA has the ability to integrate sidewalk defect data with the Village's existing GIS environment, so staff will have the ability to access data immediately upon capture. Project status will also be captured in real-time meaning the Village will know exactly what has been completed at all times, with direct access to defect information and photographs to aid in the maintenance planning process.

Using high-precision GPS devices paired with GIS field applications, GHA can capture sidewalk data quickly and accurately. GHA will capture defect locations using a survey-grade GPS device, meaning repair crews will have no issues locating defects for repair. The resulting product will be an accurately mapped sidewalk network with defect locations. This product will set the foundation for the Village's sidewalk maintenance program for years to come, and can be tracked and updated using ESRI-based tools already included with the Village's ESRI account.

Using the Village's existing GIS infrastructure as an asset management tool will allow Village staff to make quick and intelligent decisions regarding sidewalk maintenance. Combining this data with the Village's ADA ramp survey data will create a comprehensive sidewalk inventory that Village staff can use to plan projects, as well as track and assign maintenance tasks. Taking this approach will allow the Village to gain the most from their investment in this project.
