



## ORLAND PARK

### **ADDENDUM A TO 2024 CHC WELLBEING – ON-SITE WELLBEING SCREENING, DATED AUGUST 12, 2024, AMENDED NOVEMBER 18, 2024, BETWEEN THE VILLAGE OF ORLAND PARK AND CHC WELLNESS, INC., DBA CHC WELLBEING, INC.**

WHEREAS, August 12, 2024, a certain Agreement between the VILLAGE OF ORLAND PARK (hereinafter referred to as "Village") and CHC Wellness, Inc., DBA CHC Wellbeing, Inc. (hereinafter referred to as "Consultant") for the performance of certain professional services for the Village in connection with 2024 CHC Wellbeing - On-site Wellbeing Screening (hereinafter referred to as the "Project", the "Work", or the "Services") was executed (hereinafter referred to as the "Agreement"); and,

WHEREAS, the Village wishes to modify, COMPENSATION, CONTRACT DOCUMENTS:

NOW, THEREFORE, for and in consideration of the foregoing and the mutual covenants herein contained, it is agreed by and between the parties hereto as follows:

1. In the event of any conflict or inconsistency between the provisions of this Addendum A and the Agreement, the provisions of this Addendum A shall control.
2. **COMPENSATION** in said Agreement shall be amended to strike "A total amount of \$33,000.00"; and replace with "A not-to-exceed contract amount of \$34,495.00. Contract was increased by \$1,495.00 due to additional health & wellness screenings per the final invoice C7320.02 dated November 8, 2024.
3. **THE CONTRACT DOCUMENTS** of said Agreement shall be amended to include Addendum A, dated November 18, 2024.
4. All of the other terms, covenants, representations and conditions of said Agreement not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.

This Addendum A made and entered into effective the **18<sup>th</sup>, day of November, 2024**, shall be attached to and form a part of the Agreement dated the **12<sup>th</sup>, day of August, 2024**, and shall take effect upon signature below by duly authorized agents of both parties.
