ADDENDUM A TO BASEBALL FIELD LIGHTING AT JOHN HUMPHREY COMPLEX DATED NOVEMBER 4, 2024, BETWEEN THE VILLAGE OF ORLAND PARK AND MUSCO SPORTS LIGHTING LLC

WHEREAS, on November 4, 2024, a certain Agreement between the VILLAGE OF ORLAND PARK (hereinafter referred to as “Village”) and Musco Sports Lighting LLC (hereinafter referred to as “Contractor”) for the performance of certain professional services for the Village in connection with Baseball Field Lighting at John Humphrey Complex (hereinafter referred to as the “Project”, the “Work”, or the “Services”) was executed (hereinafter referred to as the "Agreement"); and,

WHEREAS, the Village wishes to modify SCOPE OF WORK AND PAYMENT.

NOW, THEREFORE, for and in consideration of the foregoing and the mutual covenants herein contained, it is agreed by and between the parties hereto as follows:

1. In the event of any conflict or inconsistency between the provisions of this Addendum and the Agreement, the provisions of this Addendum shall control.
2. **SECTION 1: SCOPE OF THE WORK** of said Agreement shall be amended to include the “Scope of Work” as set forth in Contractor’s Proposal, dated April 2, 2025. The scope of work was revised to include mobilization of large drill rigs and extra manpower to excavate asphalt and concrete at the site.
3. **SECTION 2: COMPENSATION** in said Agreement shall be amended to strike “a not-to-exceed amount of \$1,245,200.00” and replace it with a new not-to-exceed amount of \$1,273,200.00. The contract increased by \$28,000.
4. **SECTION 4: THE CONTRACT DOCUMENTS** of said Agreement shall be amended to include Addendum A, dated April 3, 2025, and “Proposal for Work, dated April 2, 2025”.
5. All of the other terms, covenants, representations and conditions of said Agreement not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.
6. This Addendum A may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.

This Addendum, made and entered into effective the **3rd day of April, 2025**, shall be attached to and form a part of the Agreement dated the 11th day of November, 2024, and shall take effect upon signature below by duly authorized agents of both parties.

IN WITNESS WHEREOF, the parties have caused this Addendum to be executed by their duly authorized officer in quadruplicate counterparts, each of which shall be considered as an original.
