

The Village of Orland Park, Illinois ("VILLAGE") and Pizzo & Associates, Ltd. ("CONTRACTOR")

WHEREAS, on September 22, 2017, a certain Agreement regarding Wooded Path II Estates – Naturalized Landscape Services between the Village and the Contractor was executed (hereinafter referred to as the "Agreement"); and,

WHEREAS, the Village wishes to modify SCOPE OF WORK AND PAYMENT.

NOW, THEREFORE, for and in consideration of the foregoing and the mutual covenants herein contained, it is agreed by and between the parties hereto as follows:

1. In the event of any conflict or inconsistency between the provisions of this Addendum and the Agreement, the provisions of this Addendum shall control.
2. SECTION 1: THE CONTRACT DOCUMENTS of said Agreement shall be amended to include Addendum A dated January 29, 2018: and "Proposal for Work dated 11/22/2017"
3. SECTION 2: SCOPE OF THE WORK AND PAYMENT of said Agreement shall be amended to strike the words "as detailed in the proposal dated May 12, 2017. Services include three (3) visits per site (Fall 2017, Spring 2018, Fall 2018)" and replace with "as detailed in the proposal dated November 22, 2017. Services include three (3) visits per site during 2018."
4. SECTION 2: SCOPE OF THE WORK AND PAYMENT of said Agreement shall be amended to strike the words "Total: an amount not to exceed Thirteen Thousand Twenty-Nine and No/100 (\$13,029.00) Dollars" and replace with "Total: an amount not to exceed Fourteen Thousand Thirteen and No/100 (\$14,013.00) Dollars"
5. SECTION 4: TERM OF THE CONTRACT of said Agreement shall be amended to include strike the words "This Contract shall terminate upon completion of the WORK December 31, 2018]" and replace with "This Contract shall terminate upon completion of the WORK or December 31, 2018,"
6. All of the other terms, covenants, representations and conditions of said Agreement not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.
7. This Addendum may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.




