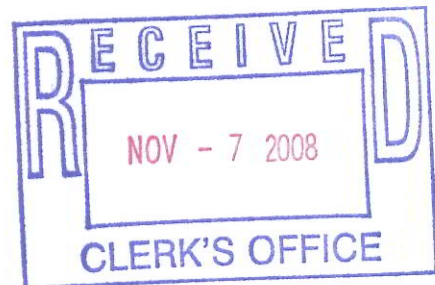

1. In the event of any conflict or inconsistency between the provisions of this Amendment and the Agreement, the provisions of this Amendment shall control.
 2. Due to the many changes that have occurred with land acquisitions, redesign of the left turning lanes affecting the Intersection Design Study (IDS) and traffic signal design and comments from IDOT, an unexpected amount of additional time has been expended to complete the required tasks of the agreement. Since the original proposal of \$8,500, an additional \$44,850 has been Board approved as specified below.

3. An additional \$36,000.00 is required to finalize the project. This was Board approved on October 6, 2008. The following is a breakdown of the additional costs:

1. Funds to cover costs already invoiced to the Village but being held	\$4,228.95
2. Costs incurred since the last billing but yet to be invoiced	\$3,085.00
3. Anticipated funds needed to obtain approval of the Jefferson Ave. access & respond to additional requests on the condemnation case	\$3,300.00
4. Anticipated funds needed to respond to potential further comments from IDOT to obtain approval of the Traffic Study, IDS and access permits	\$5,400.00
5. Funds needed to develop the traffic signal design plans	<u>\$20,000.00</u>

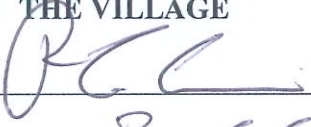

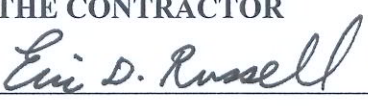
