The following is a review of the following documents pursuant to requirements of Section 6-305 Landscaping and Bufferyards:

- Landscape Plans, by Design Collective dated April 13, 2012
- Village Board Meeting Minutes, dated August 9, August 15, and September 19, 2011

### **Bufferyards**

On this site, there are no bufferyards due to the development being part of an overall transit-oriented development.

### **General Comments**

Overall the proposed plan meets the purpose and vision of the “Village Center District” of the Land Development Code of creating mixed-use walkable neighborhoods in the heart of the Village.

### **Foundation Plantings**

Section 6-305 S.10 requires a minimum 10-foot-wide landscape area fronting 70 percent of the sides of the majority of the proposed buildings. The petitioner has provided the required foundation plantings. However, it is recommended that the petitioner revise the plant material to include a larger diversity in plant species. It is recommended to avoid planting monocultures of any one type of tree or shrub. By including a diversity of plant species, the soil and beneficial insect populations are benefited. A less complex plant population favors insect and disease outbreaks. When attacks occur, replacement costs are much higher in a monoculture than in a diverse planting.

### **Parking Lot/Landscape Islands**

Parking is via the parking garage, the requirements do not apply.

### **Parkway Trees**

The parkway trees were approved via the overall development.

### **Tree Preservation**

To our knowledge, no tree survey has been submitted. As stated in the Village Ordinance, any mature trees over 4-inches in size must be mitigated if removed.

### **Detention**

Detention was approved via the overall transit-oriented development.

**Wetlands**

To our knowledge, there are no wetlands on site. It is our assumption that the Village has documentation to confirm the absence of wetlands on the property as well as within 50 feet of the property lines.

**Recommendation**

Based on the aforementioned memos and plans, we recommend accepting the Landscape Plans prepared by Design Collective dated April 13, 2012 based on the following conditions.

- The petitioner revises the plant material to include a larger diversity in plant species.
