**ADDENDUM C TO C19-0039 TURF FERTILIZATION AND BROADLEAF WEED CONTROL,
DATED MARCH 8, 2019, AMENDED FEBRUARY 4, 2021 AND OCTOBER 11, 2021,
BETWEEN
THE VILLAGE OF ORLAND PARK AND ETERNALLY GREEN LAWN CARE, INC.**

WHEREAS, on March 8, 2019, a certain Agreement between the VILLAGE OF ORLAND PARK (hereinafter referred to as "Village") and Eternally Green Lawn Care, Inc. (hereinafter referred to as "Contractor") for the performance of certain professional services for the Village in connection with Turf Fertilization and Broadleaf Weed Control (hereinafter referred to as the "Services") was executed (hereinafter referred to as the "Agreement"); and,

WHEREAS, on February 4, 2021, a certain Agreement between the Village and the Contractor for the Services was previously amended (hereinafter referred to as the "Addendum A");

WHEREAS, on October 11, 2021, a certain Agreement between the Village and the Contractor for the Services was previously amended (hereinafter referred to as the "Addendum B");

WHEREAS, the Village wishes to modify the **CONTRACT DOCUMENTS**.

NOW, THEREFORE, for and in consideration of the foregoing and the mutual covenants herein contained, it is agreed by and between the parties hereto as follows:

1. In the event of any conflict or inconsistency between the provisions of this Addendum and the Agreement, the provisions of this Addendum shall control.
2. **SECTION 1: THE CONTRACT DOCUMENTS** of said Agreement shall be amended to include Addendum C, dated November 1, 2022: and strike the Contractor's Name "Eternally Green Lawn Care, Inc." and replace with "Outdoor Home Services LLC (dba Trugreen and Action Pest Control)" hereinafter referred to collectively as the "CONTRACTOR".
3. All of the other terms, covenants, representations and conditions of said Agreement not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.
4. This Addendum may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.

This Addendum, made and entered into effective the 1st day of November, 2022, shall be attached to and form a part of the Agreement dated the 8th day of March, 2019, amended February 4, 2021, and October 11, 2021, and shall take effect upon signature below by duly authorized agents of both parties.

IN WITNESS WHEREOF, the parties have caused this Addendum to be executed by their duly authorized officer in quadruplicate counterparts, each of which shall be considered as an original.
