WHEREAS, on August 22, 2017, a certain Agreement regarding Wood Floor Refinishing 2017-2019 between the Village and the Contractor was executed (hereinafter referred to as the "Agreement"); and,

WHEREAS, the Village wishes to modify the SCOPE OF WORK.

NOW, THEREFORE, for and in consideration of the foregoing and the mutual covenants herein contained, it is agreed by and between the parties hereto as follows:

1. In the event of any conflict or inconsistency between the provisions of this Addendum and the Agreement, the provisions of this Addendum shall control.
2. **SECTION 1: THE CONTRACT DOCUMENTS** of said Agreement shall be amended to include "Addendum A dated August 22, 2018" and "Proposal dated August 16, 2018"
3. **SECTION 2: SCOPE OF THE WORK AND PAYMENT** of said Agreement shall be amended to include the following: 2018 additional work to include painting three (3) pickle ball courts on the Sportsplex gym floor per proposal dated August 16, 2018.
4. All of the other terms, covenants, representations and conditions of said Agreement not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.
5. This Addendum may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.

This Addendum, made and entered into effective the 22nd day of August 2018, shall be attached to and form a part of the Agreement dated the 22nd day of August, 2017 and shall take effect upon signature below by duly authorized agents of both parties.
