



## ORLAND PARK

**ADDENDUM A TO KENWORTH CHASSIS & PLOW/DUMP BODY PURCHASE, DATED AUGUST 28, 2023,  
BETWEEN  
THE VILLAGE OF ORLAND PARK AND HENDERSON PRODUCTS, INC.**

WHEREAS, on August 28, 2023, a certain Agreement between the VILLAGE OF ORLAND PARK (hereinafter referred to as "Village") and Henderson Products, Inc. (hereinafter referred to as "Contractor") for the performance of certain professional services for the Village in connection with Kenworth Chassis & Plow/Dump Body Purchase (hereinafter referred to as the "Project", the "Work", or the "Services") was executed (hereinafter referred to as the "Agreement"); and,

WHEREAS, the Village wishes to modify GOODS TO BE PURCHASED, NOT TO EXCEED PAYMENT, and CONTRACT DOCUMENTS.

NOW, THEREFORE, for and in consideration of the foregoing and the mutual covenants herein contained, it is agreed by and between the parties hereto as follows:

1. In the event of any conflict or inconsistency between the provisions of this Addendum A and the Agreement, the provisions of this Addendum A shall control.
2. **SECTION 1: GOODS TO BE PURCHASED** of said Agreement shall be amended to include the "Scope of Work" as set forth in Contractor's Proposal, dated February 27, 2024.
3. **SECTION 2: NOT TO EXCEED PAYMENT** in said Agreement shall be amended to strike "not to exceed \$362,462.00" and replace with "not to exceed \$366,841.00".
4. **SECTION 4: THE CONTRACT DOCUMENTS** of said Agreement shall be amended to include Addendum A, dated March 18, 2024, and "Proposal for Work, dated February 27, 2024."
5. **SECTION 5: DELIVERY DATE** of said Agreement shall be amended to strike "no later than December 15, 2023" and replace with "no later than June 10, 2024."
6. All of the other terms, covenants, representations and conditions of said Agreement not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.
7. This Addendum A may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.

This Addendum A, made and entered into effective the **18<sup>th</sup> day of March, 2024**, shall be attached to and form a part of the Agreement dated the August 28, 2023, and shall take effect upon signature below by duly authorized agents of both parties.

IN WITNESS WHEREOF, the parties have caused this Addendum A to be executed by their duly authorized officer in quadruplicate counterparts, each of which shall be considered as an original.
