UNDERSTANDING OF THE VILLAGE'S METER CONVERSION PROCESS

**The Village of Orland Park
Proposed Water Meter Replacement Plan
October 19, 2022**

Calumet City Plumbing (CCP) is pleased to present our proposed Methodology for scheduling, installation, and data management of the 2023-2024 Water Meter infrastructure upgrade for The Village of Orland Park (VOP). All water meters, transmitters, touch pads, wire and meter gaskets are to be supplied by the owner. Labor, equipment, appointment scheduling and data collection software are to be supplied by Calumet City Plumbing.

The Meter Replacement System will consist of the following:

Calumet City Plumbing to install water meters and transmitters (where needed). The majority of the interior meter replacements have the transmitters mounted on the outside of the building. All Pit meter replacements will have the transmitters mounted on the meter vault lid.

Village of Orland Park supplied Meters and support material will be available to CCP to have 24-hour access to the meter inventory and or old meter storage facility.

Meter Material to be supplied by the Village:

1. Meters 5/8" to 1" will be Sensus Iperl meters with touch-couple Flex Net transmitters.
2. Meters 1-1/2" to 4" will be Sensus Omni+ Meters with touch-couple Flex Net transmitters.
3. Meter gaskets, touch pads.
4. All Meters to be activated and/or programed by CCP using The Village of Orland Park Field Logic Configuration File (Provided by Core & Main).

Our Water Meter Installation program and procedures will provide The Village with quality installation performed by experienced licensed plumbers. Our plumbers and staff have passed an extensive background check.

We provide Project Management and Planning for scheduling of all appointments, meter installation, real-time data collection and retrieval for the VOP during the project, water service line material type inventory, daily, weekly and monthly reporting, and data files that can be converted and directly imported into the Village billing system. They Physical import to be performed by the Village.

Throughout the project, CCP will provide a listing of any non-responsive accounts, inaccessible meters, meters with non-working service valves illegal connections before the meter or location at which meters cannot otherwise be replaced. CCP will work with VOP to solve, correct, and install all that can be completed during the duration of the contract. At the close of the project, CCP will provide VOP with a file containing all Data and photographs captured during the project.

The VOP will be required to provide a detailed data file by spreadsheet with the following information:

- Account number
- Old meter serial number & existing transmitter number.
- Route or section number (based on read routes or other)
- Location type distinguishing Inside Set Meter or Pit Meter
- Old meter information (serial number, register number, transmitter number)
- Owner information: Name, address, Phone number
- Service location: Name of resident, address, Phone number
- Any other distinguishing information that will be helpful to identify the meter and or location.

The Process: Once the VOP data file has been provided to CCP with all the Water Service locations, their owners, mailing addresses, size and type of the existing water meter, the data is downloaded into our system, the mailing process will begin.

General Mail Plan: A series of letters, post cards and door tag notifications will be provided for review and approval prior to solicitation of any appointments.

Inside Set Meters:

1. The VOP to mail a “Kickoff” or introduction letter to all the service addresses and owners.
2. Approximately 2 weeks later, CCP to mail approximately 500 Initial letters and adjust for future mailing based on appointments made.
3. To those who do not make an appointment, a reminder Post Card will be sent 7 calendar days after the initial letter.
4. If an appointment is not made after the initial letter and the post card, a second reminder Post card will be mailed to the owner and service address.
5. If no appointment is made at that point, CCP will perform a Door Tag and hand deliver a final notice / water suspension letter. This will give the resident 5 days to call and make an appointment. If no appointment has been made, this account will be turned over to VOP. The Village can choose to post their own notice or turn the water off.
6. CCP will make no further attempt to contact the owner(s). However, CCP will assist with installing the meters as directed by the Village until either completion or other resolution.

This mail process from CCP will take approximately (4) weeks in each section. This process repeats itself until all new accounts have been notified according to the contract.

Pit Meters:

1. VOP to mail a “Kickoff” or introduction letter to all the service addresses and owners.
2. Approximately 2 weeks later, CCP to mail a Pit Meter letter based on the section of the Village that is being worked in. An appointment will only be necessary if the resident has

a locked gate or fence around the meter pit, or if they want to be home during the replacement. Otherwise, CCP will change the meter and leave a note on the door as to the date and time it was replaced.

Appointment Scheduling:

CCP will team up with M. E. Simpson for its scheduling of appointments, data collection and housing during the project.

Water customers will have the option of scheduling their appointment online to streamline the process or call our operator at (888) 252-1521. Online scheduling is fast and easy. To access the scheduling system simply go to www.ccp1967.com, and select the "Meter Appointment" blue tab at the top of the page, select The Village of Orland Park and follow the prompts.

Installation times:

We offer several convenient time blocks. Included in our bid are the following "typical" time blocks:

8:00 AM to 6:00 PM Monday through Thursday (**NO** Friday appointments).

Time blocks: 8:00 to 12:00, 12:00 to 4:00 and 4:00 to 6:00

8:00 AM to 4:00 PM Saturday (**NO** Sunday Appointments)

Time blocks: 8:00 to 12:00 and 12:00 to 4:00

Note: For water critical accounts, work can be scheduled other times. Our Project management team will perform a site survey and work this the resident or business owner to replace the meter at a convenient time.

Data Collection / Retrieval & Reporting:

CCP installers use iPad or smart phones to verify the old meter data & collect the new meter data. Backup photos for all facets of our installation process will be taken.

Included in our data package, (1) Water Department Representative will have access to our system and will be able to monitor the daily schedule, installations as they are entered, and daily totals and reports all in real time. This access will be available during the entire time the contract is open. Once closed, a file will be presented with all the data and photos from the project. Custom report will be created so the new installation information can be uploaded into the municipal billing system. Uploading or importing the data to be performed by the Village.

Included in the Proposal:

1. CCP will provide labor and material to remove and replace the existing water meters as directed. Meters are to be the same Lay Length as the existing meters (Drop In's), with no additional re-piping to complete the installation.
2. All Inside Set meters will have the Transmitter mounted outside the structure. Any exterior mounted transmitter will be installed using existing wire. Additional cost will apply for running new wire if required.
3. All Pit meter transmitters will be mounted on the existing meter lid.
