



WHEREAS, on August 8, 2017, a certain Agreement regarding Crack Sealing for Department of Public Works Unit Pricing 2014-2016 between the Village and the Contractor was executed (hereinafter referred to as the "Agreement"); and,

WHEREAS, the Village wishes to extend the term of the agreement.

NOW, THEREFORE, for and in consideration of the foregoing and the mutual covenants herein contained, it is agreed by and between the parties hereto as follows:

1. In the event of any conflict or inconsistency between the provisions of this Addendum and the Agreement, the provisions of this Addendum shall control.
2. SECTION 1: THE CONTRACT DOCUMENTS of said Agreement shall be amended to include Addendum A dated June 14, 2017 and Proposal dated October 31, 2016
3. SECTION 2: SCOPE OF THE WORK AND PAYMENT of said Agreement shall be amended to strike "2014-2016" under Unit Prices and replace with "2014-2017"
4. SECTION 4: TERM OF THE CONTRACT of said Agreement shall be amended to strike "2016" in the sentence "...and shall complete performance of the WORK of this Contract by December 31, 2016" and replace with "2017."
5. All of the other terms, covenants, representations and conditions of said Agreement not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.
6. This Addendum may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.

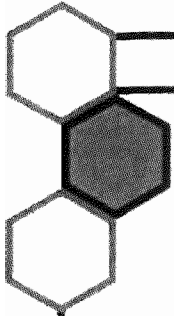
