


**Project Notes:**

- 1.0 V3 proposes to apply herbicide to nuisance herbaceous vegetation and seed shoreline buffer.
- 2.0 Prescribed burning will include a burn plan, assistance with obtaining necessary permits, and executing the burn. Conditions outside the burn prescription identified in the burn plan will be cause for stopping the burn at the sole discretion of the burn leader. A return trip to complete the burn will require additional compensation from Owner and will be dependent upon the extent of work required to complete.
- 3.0 This proposal does not include goose protection. In the event that goose activity becomes a detriment to the planting, V3 will request a change order for erecting goose enclosures.

**Contract Terms & Conditions**

- 1.0 This proposal constitutes the entire agreement between the purchaser and V3 Companies of Illinois, Ltd.
- 2.0 Net payment is due upon receipt of invoice.
- 3.0 Final payment, including any retained monies, is due immediately upon satisfactory completion of the work and receipt by purchaser of the final invoice.
- 4.0 Invoices unpaid after thirty (30) days will incur a finance charge of three percent (3.0%) per month.
- 5.0 Purchaser warrants that he/she has the authority to make this agreement.
- 6.0 This contract is limited to the work identified. Any additional work will be agreed to by change order and made a part of this agreement.
- 7.0 This contract shall be interpreted under the laws of the State of Illinois.
