Dear Mr. Limanowski:

This notification is to inform you that on November 4, 2013 the Village of Orland Park Board of Trustees approved awarding Mid America Tree & Landscape, Inc. the contract in accordance with the proposal you submitted dated September 4, 2013 for Turf Mowing for three years (2014, 2015, 2016) at the 2010 price per acre of \$19.75, minimum cost \$9.00. Nuisance mowing will be charged a rate of \$45.00 per acre.

Turf Mowing Contract

Between

The Village of Orland Park, Illinois ("VILLAGE") and Mid-America Tree & Landscape, Inc. ("CONTRACTOR")

RE: Extension of contract for three (3) additional years (2014, 2015 & 2016) at the 2010 prices.

1. In the event of any conflict or inconsistency between the provisions of this Addendum and the Agreement, the provisions of this Addendum shall control.
2. In **SECTION 19: Term of Agreement** of said Contract, the sentence "This Agreement shall become effective upon execution of said Agreement by both parties and shall remain in effect up to and including midnight, December 31, 2013" shall be stricken and replaced with the following sentence "This Agreement shall become effective January 1, 2014 and shall remain in effect up to and including midnight, December 31, 2016."
3. All of the other terms, covenants, representations and conditions of said Agreement, not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.
4. This Addendum may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.

This Addendum, made and entered into effective the **1st day of January, 2014**, shall be attached to and form a part of the Agreement dated the 20th day of December, 2007 and shall take effect upon signature below by duly authorized agents of both parties.




Dear Mr. Ingram,
