****Pool Shuttles:** We will charge a hourly rate for shuttling various camps to and from the pool. If the bus is to wait (cannot return to base) then the wait time rate is charged at \$45.00/hr. If the bus can return to base and the time between shuttles is more than one hour, then we would only charge for "live" shuttle time.


In order to give you the service you require, we propose the hourly rate and would apply it to all trips indicated. The buses may be used for any type combination of shuttling and/or trips on the same day. We would ask that you give us as much notification as possible when changing a trip from one destination to another. However, we do understand weather conditions and assure you that there will be no problem in changing a bus from one place to another, at adding another stop to it; i.e., a swim bus changed due to rain to take the children to another camp, etc. Please keep in mind that our charges to you start when "the bus arrives at your pickup location"- not when it leaves our garage. Also we are not adding a fuel surcharge to any of your hourly rates. Cancellation charges are assessed when a trip is cancelled less than two (2) hours prior to the pickup time indicated. In this way, we have time to notify our driver before they leave their home and can save you the additional cost. Most companies hold to a 24 to 48 hour policy on cancellations. We do background checks on all of our drivers and the drivers that will be providing service to your camp, we will provide those to you.


