5-4-3: MODIFICATIONS:

The following Sections shall be amended in the following respects:

1. Section 890.310 shall be amended to add at the end of the section the following words: "All copper water tubing, when installed underground shall be a minimum of Type K, and when inside a building shall be a minimum of Type L.
- 1a. Section 890.320n is amended to add at the end of the section the following sentence: "In-ground installations may not use no-hub soil pipe joints." (Ord. 3798, 9-2-03)
2. Section 890.330(c) shall be amended to delete the reference to CVPC.
3. Section 890.810(b)(2)(B)(i), Restaurants, shall be amended to delete the language at the end of the subsection excepting small restaurants from the provisions of the subsection.
4. Section 890.1140(d) is amended to add at the end of the subsection: Any lawn sprinkler controls, piping or appendages placed in public rights-of-way shall be located not less than three (3) feet from any existing or planned public street curb and gutter line. ***"The Village shall not be responsible for the maintenance of private lawn sprinkler systems within the public rights-of-way. The property owner assumes all risk involved in choosing to place lawn sprinkler components in the public rights-of-way. Furthermore, the Village of Orland Park shall not be responsible for the restoration or repair of private sprinkler systems due to construction activities within the public rights-of-way."*** In addition, all lawn sprinkler systems shall be equipped with an approved rain detection device. (Ord 3700, 10-21-02).
5. Section 890.1320(c) is amended to add the following language at the end of the subsection:

All water supply piping and drainage traps located in garage ceilings will be protected from freezing by one of the following methods.

- a. Installation of heat in the garage sufficient to insure a minimum 50 degree temperature;
 - b. Provision of heat from the building heating supply into those joint spaces containing the water supply piping or drainage traps. (Ord. 2736, 6-6-95)
6. Section 890.1940 shall be amended to delete the entire text and substitute the following language:

(9/05)

a. PERMIT REQUIRED.

- (1) No plumbing work whether new construction or alteration shall be undertaken by any person, firm or corporation unless a permit has been issued therefor. The plumbing permit may be included on the Village Building Permit.
- (2) A plumbing permit shall only be issued to a licensed plumber, except as specified in (3), below.
- (3) In the case of a single family residence, a plumbing permit may be issued to the owner/occupant or lessee/occupant of said residence. Further, such owner/occupant or lessee/occupant shall only employ a licensed plumber.

b. APPLICATION.

Application for a plumbing permit shall be made on the forms provided by the Village Building Department. Said application shall be accompanied by the fees established by Ordinance.

c. ISSUANCE OF PERMIT, VIOLATIONS.

No plumbing permit shall be issued until after plans and specifications showing the proposed plumbing work have been submitted, reviewed and approved by the Village Building Department. If a plumbing permit is denied, the applicant shall submit revised plans and specifications. When it is found necessary to make any change in the plumbing from the plans and specifications on which a permit has been issued, amended plans and specifications shall be submitted to the Village Building Department for approval prior to actual making of any change in the plumbing system.

- (1) Any person, firm or corporation who installs, alters or otherwise undertakes any plumbing work without a permit shall be guilty of a petty offense punishable by a fine of not less than Fifty (\$50.00) Dollars nor more than Seven Hundred Fifty (\$750.00) Dollars upon conviction. Each day that as violation exists shall be deemed a separate offense.

- (2) Any person, firm or corporation who installs, alters or otherwise undertakes any plumbing work and fails or refuses to execute the work in accordance with the approved plans shall be guilty of a petty offense punishable by a fine of not less than Fifty (\$50.00) Dollars nor more than Seven Hundred Fifty (\$750.00) Dollars upon conviction. Each day that a violation exists shall be deemed a separate offense.

- (3) Any person, firm or corporation who fails or refuses to comply with the rules and regulations contained in this Plumbing Code shall be guilty of a petty offense punishable by a fine of not less than Fifty (\$50.00) Dollars nor more than Seven Hundred Fifty (\$750.00) Dollars upon conviction. Each day that a violation exists shall be deemed a separate offense.
