WHEREAS, on October 20, 2020, a certain Agreement regarding Vehicle Maintenance and Repair between the Village and the Contractor was executed (hereinafter referred to as the "Agreement"); and,

WHEREAS, on October 18, 2021, a certain Agreement regarding Vehicle Maintenance and Repair between the Village and the Contractor was amended (hereinafter referred to as the "Addendum A"); and

WHEREAS, the Village wishes to modify SCOPE OF WORK AND PAYMENT.

NOW, THEREFORE, for and in consideration of the foregoing and the mutual covenants herein contained, it is agreed by and between the parties hereto as follows:

1. In the event of any conflict or inconsistency between the provisions of this Addendum and the Agreement, the provisions of this Addendum shall control.
2. SECTION 1: THE CONTRACT DOCUMENTS of said Agreement shall be amended to include Addendum A dated October 18, 2021: and "Proposal for Work dated October 4, 2021"
1. SECTION 2: SCOPE OF THE WORK AND PAYMENT of said Agreement shall be amended to include:
  - Labor rate per hour increased from \$135 per labor hour to \$141 per labor hour.
  - Labor for brake jobs increased by \$20 per axle.

3. SECTION 2: SCOPE OF THE WORK AND PAYMENT of said Agreement shall be amended to add the words:
  - These prices changes are reflecting the results of the current union contract increases as of August, 2021.
4. SECTION 4: TERM OF THE CONTRACT of said Agreement shall be amended to one (1) renewal year.
5. All of the other terms, covenants, representations and conditions of said Agreement not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.
6. This Addendum may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.

This Addendum, made and entered into effective the 1 January 2022 through 31 December 2022, shall be attached to and form a part of the Agreement dated the October 20, 2020, amended October 18, 2021, and shall take effect upon signature below by duly authorized agents of both parties.
