



## ORLAND PARK

**ADDENDUM B TO CENTENNIAL PARK WEST LIGHTING, SOUND, TRUSS, RIGGING &  
OTHER RENTAL EQUIPMENT, DATED MARCH 18, 2024, AMENDED MAY 19, 2025,  
BETWEEN  
THE VILLAGE OF ORLAND PARK AND SOUND WORKS PRODUCTIONS DBA VANTAGE  
PRODUCTION GROUP**

WHEREAS, on March 18, 2024 a certain Agreement between the VILLAGE OF ORLAND PARK (hereinafter referred to as "Village") and Sound Works Productions dba Vantage Production Group (hereinafter referred to as "Consultant") for the performance of certain professional services for the Village in connection with Centennial Park West Lighting, Sound, Truss, Rigging & Other Rental Equipment (hereinafter referred to as the "Project", the "Work", or the "Services") was executed (hereinafter referred to as the "Agreement"); and,

WHEREAS, on May 19, 2025, a certain Agreement between the Village and the Consultant for the Centennial Park West Lighting, Sound, Truss, Rigging & Other Rental Equipment was previously amended (hereinafter referred to as the "Addendum A");

WHEREAS, the Village wishes to modify **SCOPE OF WORK, COMPENSATION, AND CONTRACT DOCUMENTS**.

NOW, THEREFORE, for and in consideration of the foregoing and the mutual covenants herein contained, it is agreed by and between the parties hereto as follows:

1. In the event of any conflict or inconsistency between the provisions of this Addendum B and the Agreement, the provisions of this Addendum B shall control.
2. **SECTION 1: SCOPE OF THE WORK** of said Agreement shall be amended to include the "Scope of Work" as set forth in Consultant's Proposals 13877-8 and 13882-5, dated July 29, 2025, due to the rental of scissor lifts for hanging light and sound gear for the Centennial Park West August 8 & 20, 2025 concerts.
3. **SECTION 2A: COMPENSATION** in said Agreement shall be amended to strike the "not-to-exceed amount of 137,800.00, for FY2025" and replace with a new "not-to-exceed amount of \$138,400.00 for FY 2025, and the not-to-exceed Board approval amount for 2026". The FY 2025 contract amount increased by \$600.00.
4. **SECTION 3: THE CONTRACT DOCUMENTS** of said Agreement shall be amended to include Addendum B, dated August 4, 2025: and "Proposals for Work, dated July 29, 2025.
5. All of the other terms, covenants, representations and conditions of said Agreement not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.
6. This Addendum B may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.

This Addendum B, made and entered into effective the **4<sup>th</sup> day of August, 2025** shall be attached to and form a part of the Agreement dated the 18<sup>th</sup> day of March 2024, amended May 19, 2025, and shall take effect upon signature below by duly authorized agents of both parties.

IN WITNESS WHEREOF, the parties have caused this Addendum B to be executed by their duly authorized officer in quadruplicate counterparts, each of which shall be considered as an original.
