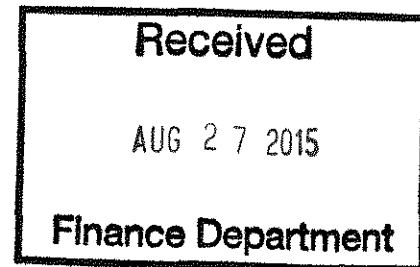

WHEREAS, on February 17, 2014, a certain Agreement regarding LaGrange Road Corridor Enhancement between the Village and the Contractor was executed (hereinafter referred to as the "Agreement"); and,

WHEREAS, the Village wishes to modify the SCOPE of the work.

NOW, THEREFORE, for and in consideration of the foregoing and the mutual covenants herein contained, it is agreed by and between the parties hereto as follows:

1. In the event of any conflict or inconsistency between the provisions of this Modification and the Agreement, the provisions of this Modification shall control.
2. **ARTICLE 12: SCOPE OF THE AGREEMENT §12.2.3.1** of said Agreement shall be amended to include "(2015 BUDGET SUMMARY – EAST CORRIDOR IMPROVEMENTS)"
3. All of the other terms, covenants, representations and conditions of said Agreement and not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.
4. This Addendum may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.

This Addendum, made and entered into effective the 3rd day of August, 2015, shall be attached to and form a part of the Agreement dated the 17th day of February, 2014 and shall take effect upon signature below by duly authorized agents of both parties.
