2011-0583 Clock Tower Extra Work Quote

Park's Division Director Frank Stec reported that Robert Juris & Associates Architects, Ltd. is to provide structural engineering services for re-anchoring the metal trellis back to the existing clock tower. The original Perkins and Will drawings did not have any details on how it was anchored and the method wasn't known until demolition of the face brick began last week. Staff recommends that we have the structural engineer review the existing detail, evaluate and recommend the reuse of the detail; or recommend a new detail (more likely), at a cost of \$1600.00.

2011-0686 Police Station Bypass System Emergency Repairs

Director Stec reported that the village received an invoice for the repair of the Bypass System at the Orland Park Police Station. This unit is necessary to keep the Police Station up and running in the event of the need to switch from the main ComEd power to generator power. This system failed August 19, 2011, causing the station to be without power for at least 20 minutes until the Building Maintenance Department was able to manually switch power back on. This caused 911 operations to be halted and transferred to other 911 centers.

2011-0617 2012 Special Recreation Vacation Trip

Recreation Division Director Nancy Flores reported that the Recreation and Parks Special Recreation program is planning their annual vacation trip. This year, the group will be traveling to Sandpiper Resort, Club Med, Port St. Lucie, FL., Monday, August 27 - Friday, August 30, 2012. A summer trip has been offered for the past 11 years and is very well attended. The registration is estimated to be 20-25 people. The vacation trips are not subsidized by the Village and are planned on a break-even basis.

The cost of the trip is estimated and budgeted at \$37,770.00. A previously paid deposit of \$683.00 will be deducted from this total. At this time, staff is requesting approval for the Village to pay the up-front deposit of \$4,770.00 to Carol's Travel of Tinley Park. A second deposit of \$4,410.00 is due April 1, 2012 and the final payment will be due June 14, 2012. Expenses for this trip will be met by registration revenues.

I move to recommend to the Village Board to approve a deposit payment of \$4,777.00 to Carol's Travel of Tinley Park for the Special Recreation vacation trip; and payment of the second deposit, followed by the balance at invoicing, prior to departure.

2011-0616 Pytel Solar Energy System Installation - Appearance Review

Director of Development Services Karie Friling reported that the purpose of this petition is to install a 4.8 kW Solar Energy System on the rooftop of a single family home at 18233 Lake Shore Drive in the Breckenridge subdivision.

In October 2010, the Village Board of Trustees approved amendments to the Land Development Code that created Section 6-314 Environmental Technology Standards. The new section included development information and regulations regarding the appropriate implementation of renewable energy systems in the Village. These include wind energy conversion systems, solar energy systems and geothermal energy systems.

As a result of these regulations now making renewable energy accessible to Orland Park residents and businesses, the petitioner proposes a solar energy system (SES) to locate on two southwestern facing gabled rooftops of his single family home. This is only the second project of its kind in the Village, the first being the Raman Residence at 7701 W. 157th Street.

The petitioner is proposing to install twenty (20) photovoltaic (PV) solar panels as a single array on two southwestern facing gabled rooftops of his single family home. Each Sharp Solar Module solar panel will provide 240 watts of power and they will be positioned on a 50 degree pitched rooftop.

The proposed system will provide approximately 5,400 kWh of electricity per year, or close to 40% of their annual electrical usage. This is a significant improvement toward energy efficiency and conservation.

PLAN COMMISSION

On October 25, 2011, the Plan Commission moved 5-0 to recommend to the Board of Trustees to approve the proposed elevation drawings titled "4.8 KW Solar Project", prepared by Good Electric Inc., dated September 14, 2011, sheets 1 of 2 and 2 of 2, for an environmental clean technology at 18233 Lake Shore Drive, subject to the following conditions:

- 1. That all building code related items are met:
- 2. That all building permits are obtained prior to construction;
- 3. That all utility conduits and systems related to the solar energy system not be visible from the street and from neighboring residential properties;

At the Plan Commission, Commissioners discussed the rooftop coverage requirements identified in the staff report and removed a condition recommended by staff that the petitioner either remove a solar panel from the second array or move a panel to another rooftop or to the first array to meet rooftop coverage requirements. The second array was proposed to cover 76% of the portion of rooftop on which it was to be located. However, Plan Commission maintained that in total the amount of rooftop facing south was much greater than the portion in question and that the solar panel array did not come close to covering 75% of all the south facing rooftops. With this understanding, Plan Commission removed the condition.

There was no opposition by any neighbors regarding this project.

Trustee O'Halloran questioned the cost of the project.

Orland Park Resident Mr. Pytel was present and stated that the total cost of the project is about \$45,000 and the State and Federal rebates cover approximately 40% to 50% of the cost.

Trustee Dodge asked Mr. Pytel if he would be interested in reporting back to the Village in a few years with an update.

I move to recommend to the Village Board to approve the proposed solar energy system environmental clean technology project for 18233 Lake Shore Drive, a single family home, as indicated in the attached fully referenced motion.
