Hello Gary,

The Dist 230 Bass Fishing Coaches were wondering if we could get added to the Parks and Rec Committee meeting agenda for Nov 21st, 2016. We were hoping to seek permission to ice fish on Lake Sedgewick this coming January or February, weather permitting. Lake Sedgewick has become our outdoor classroom, and it is our hope to use the lake in an effort to educate our kids how to ice fish as well as making them aware of the hazards of ice fishing. We would contact the Orland Fire Dept again and ask that they also attend our event, to ensure the safety of our kids. One other thing we would do on the ice, is create additional fish cribs using old Christmas trees, in an effort to improve the fish habitat/structure in the lake. We would assemble these out on the ice and they would then fall into the water when the ice melted in the Spring. Again, the fish cribs not only improve the conditions of the lake, but also allow us to teach our kids how to maintain and care for our natural/local resources. This is part of the Dist 230 S4 Initiative which supports hands on activities that teach our kids real life skills that can potentially lead to future career paths for students.
