**AMENDMENT A TO FACILITIES LOCATING AND MARKING SERVICE CONTRACT, DATED APRIL 29, 2022, BETWEEN
THE VILLAGE OF ORLAND PARK AND USIC LOCATING SERVICES, LLC**

WHEREAS, on April 29, 2022, a certain Agreement between the VILLAGE OF ORLAND PARK (hereinafter referred to as "Village") and USIC Locating Services, LLC (hereinafter referred to as "Contractor") for the performance of certain professional services for the Village in connection with Facilities Locating and Marking Service Contract (hereinafter referred to as the "Project", the "Work", or the "Services") was executed (hereinafter referred to as the "Agreement"); and,

WHEREAS, the Village wishes to modify COMPENSATION and CONTRACT DOCUMENTS.

NOW, THEREFORE, for and in consideration of the foregoing and the mutual covenants herein contained, it is agreed by and between the parties hereto as follows:

1. In the event of any conflict or inconsistency between the provisions of this Amendment A and the Agreement, the provisions of this Amendment A shall control.
2. **THE CONTRACT DOCUMENTS** of said Agreement shall be amended to include Amendment A, dated January 8, 2023.
3. **COMPENSATION** in said Agreement shall be amended to add a "total not-to-exceed amount of thirty thousand dollars and 00/100 (\$30,000.00)" for Fiscal Year 2023.
4. All of the other terms, covenants, representations and conditions of said Agreement not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.
5. This Amendment A may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.

This Amendment A, made and entered into effective the **8th day of January, 2023**, shall be attached to and form a part of the Agreement dated the 29th day of April, 2022, and shall take effect upon signature below by duly authorized agents of both parties.
