POSITION SUMMARY:

Performs crime analysis for tactical, strategic, administrative and intelligence purposes. Perform in-depth, systematic, analytical processes to provide timely and pertinent information regarding crime patterns, crime trends and crime correlations. Collects, analyzes, presents and disseminates information regarding actual and anticipated criminal activity. Assists department staff in the development, implementation and evaluation of problem-oriented policing projects and current departmental performance.

ESSENTIAL DUTIES AND RESPONSIBILITIES:

- Collect, analyze and maintain information related to criminal activity and overall department performance.
 Create, instruct and assist with responses to requests from department members in areas related to crime
 analysis, intelligence functions and Uniform Crime Reporting (UCR) reporting requirements. Analyze data
 retrieved from computer searches of internal and external databases, police department reports, reports from
 other jurisdictions, bulletins and various other open-source documents to identify crime, crime patters,
 relationships and trends. Utilize data to forecast future crime occurrences and develop target profile analyses.
- 2. Apply a variety of statistical methodologies and geographical analysis techniques to interpret complex data and produce and present related reports. Testify in court as needed.
- Design and produce various statistical, analytical and confidential products (reports, maps, spreadsheets and other documents) using a variety of computer software which may be utilized by department personnel, other law enforcement agencies at the local, state and federal levels, governing body, states attorney, local media and citizens.
- Provide direct support for both routine and significant investigations, including village-wide emergency operations.
- 5. Provide direct support for the administrative strategic and tactical functions of the police department.
- 6. Assist in suspect identification and conduct lawful and procedurally correct record checks on individuals, vehicles, licenses, weapons, etc., using various computer systems.
- 7. Maintain current knowledge of local, regional and national criminal or other law enforcement sensitive activity via computer websites relating to extremist or terroristic organizations/activities.
- 8. Read and review law enforcement sensitive intelligence databases that are extremely confidential. Properly download, preserve and protect confidential information within police department guidelines for future case prosecution.
- 9. Maintain working knowledge of rules governing records dissemination outside the department and reporting and classification standards for police reports. Maintain data in a secure and confidential manner. Review department policies to ensure compliance with federal and state guidelines for reporting and disseminating information.
- 10. Create and maintain computerized and/or physical copy files of spreadsheets, databases and other reports related to the tactical, strategic, administrative, and intelligence analysis functions of the department.
- 11. Attend and participate in various departmental meetings, roll calls and district meetings to share information.
- 12. Identify directed patrol problem areas within the police departments patrol beats.
- 13. Review the departments camera systems during criminal investigations.
- 14. Review Critical Reach Bulletins for patterns, trends and possible suspect identifiers.

15. Review and analyze recent parole releases for similar crimes and patterns.
