A RESOLUTION APPROVING AND AUTHORIZING THE EXECUTION OF A COLLECTIVE BARGAINING AGREEMENT BETWEEN THE VILLAGE OF ORLAND PARK AND ORLAND PARK POLICE SUPERVISORS ASSOCIATION (OPPSA) (2023-2028)

WHEREAS, the Village of Orland Park, Cook and Will Counties ("Village") is a municipality duly organized and operating pursuant to the 1970 Illinois Constitution and laws of the State of Illinois; and

WHEREAS, pursuant to the Illinois Municipal Code, 65 ILCS 5/8-1-7, and the Illinois Public Labor Relations Act, 5 ILCS 315/1 et seq., the Village of Orland Park is authorized to enter into collective bargaining agreements; and

WHEREAS, the Board of Trustees deems it to be in the best interests of the Village to enter into a collective bargaining agreement with Orland Park Police Supervisors Association ("OPPSA").

THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Orland Park, Cook and Will Counties, Illinois, as follows:

Section One: The collective bargaining agreement between the Village and OPPSA is hereby approved and the President and Village Clerk of the Village of Orland Park are hereby authorized to execute the agreement substantially in the form of the agreement attached hereto as Exhibit A and made a part hereof.

<u>Section Two</u>: This Resolution shall be in full force and effect upon its passage and approval as required by law.

**Section Three:** This Resolution supersedes any resolutions or motions, or parts of resolutions or motions, in conflict with any part herein, and any such resolutions or motions, or parts thereof, are hereby repealed to the extent of any conflict.
