It is our understanding that additional design engineering was required to complete the Part B final design plans for the 104th Avenue improvement. This additional engineering was performed by McDonough Associates Inc. and their sub consultant, Wang Engineering, Inc. This work consisted of the final design of the timber pile embankment platform in the poor soil area and included pile testing and analysis. A copy of the man-hours and services has been reviewed by your Department.

This engineering effort totaled \$80,565. A breakdown of the cost participation is as follows:

Design and Geotechnical Engineering for timber pile platform in poor soil area (Total - \$61,195)

\$45,896 (75% by CCHD) \$15,299 (25% by Orland Park)

Pile driving observation, testing and analysis (Total - \$19,370)

\$19,370 (100% by CCHD)

The Village of Orland Park is in agreement with the above cost participation for this work and will be responsible for a maximum amount of \$15,299, contingent upon receipt of an amendment to our original agreement. BACKGROUND:

On October 1, 2007, the Board of Trustees approved entering into an agreement with the Cook County Highway Department for Phase I and Phase II engineering for improvements to 104th Avenue from 159th Street to 167th Street. This supplemental agreement is for additional design engineering that is required for Part B final design and geotechnical engineering plans for the timber pile platform in poor soil that was requested by Cook County Highway Department. The total cost of the supplement involving the Village is \$61,195 of which the Village is responsible for \$15,299 or 25%.

On January 12, 2009, this item was reviewed and approved by the Public Works and Engineering Committee and referred to the Board for approval.

BUDGET IMPACT:
