- 1.0 Herbiciding window expires in early fall. Therefore that task will be completed in spring 2017.
- 2.0 Tree clearing does not provide stump grinding.
- 3.0 The work of this proposal will accomplish a kill and removal of the existing vegetation. Regrowth should be expected to occur at some time following herbicide application in spring 2017. Control of that growth should be part of the final plan for the basin.
- 4.0 This proposal constitutes the entire agreement between the purchaser and V3 Construction Group, Ltd.
