The following rider is in adjunct to the contractual agreement with the purchaser. This rider has been designed to accommodate a professional and enjoyable performance, the safety and overall comfort to all of those involved, and to answer any questions the purchaser may have. Some substitutions are acceptable and others are not, and American English will always be as **flexible** as possible, depending on the nature of the event. Any alterations must be approved by both Eric (Michaels) Suszynski (773) 582-9102 & Stage Manager Zachary Mishur (708) 259-0210 zgm6763@yahoo.com

#### A. Indemnification:

- 1. American English will not be liable for any personal injuries which may occur prior to, during, or after the performance
- 2. American English retains the right to cancel any performance when the safety of the talent or production crew is compromised, on the spot.
- B. <u>Parking, Hotel, and Transportation:</u> not applicable 1. IF hotel accommodations are necessary 6 to 8 rooms may be necessary and be provided at no cost to Artist. Artist will notify purchaser the number of single rooms needed, if any.
  - 2. Parking accommodations for one Full Size 16' Truck, 1 Van, and 5 cars-is necessary. ALL EXPENSES FOR PARKING TO BE PAID FOR BY PURCHASER.
  - 3. WHEN AMERICAN ENGLISH IS TRAVELING BY AIR, transportation to and from airport, hotel, and performance venue, must be-provided for Artist. At no time will American English be responsible for transportation between any necessary points of travel, or for the cost of luggage as they only carry performance related items. (Guitars, Costumes, Electronics, etc.)
- C. <u>Dressing Room & Hospitality:</u> 1. Purchaser will provide at least one large and adequately lit dressing room with one floor length mirror, and 5-comfortable chairs within 50feet of stage. If a performing Arts Center for any out of town performance, a professional clothing steamer (a working one) must be provided for the Costumes of the Artist

2. Purchaser will provide one **PRIVATE LAVATORY** exclusively for the use of the band also exclusive to Artist is a back stage Rot-A-Potty for Festivals or any outdoor events. This is Mandatory! A PRIVATE quick- change area with a full- length mirror and adequate lighting within 20 to 50 feet of the stage must be provided when the Talent is required to accommodate a quick change set.

3. The items listed shall be made available for consumption by the Artist & Crew at the time of American English's arrival. Where applicable food & beverages are to be adequately refrigerated. water + sada provided - policie Two Cases of 12 oz. bottles of spring water

One case of diet Coke or Pepsi / One 1/2 case of Regular Coke a Cola or Pepsi A-Deli assortment with various Meats, Cheeses, Fruits, Vegetables, Breads, and Condiments and the WA necessary cutlery and plate ware to accommodate 8 people for the duration of the day. At the end of event 8 hot meals are to be provided for the Artist & Crew. In a Festival situation a variety festival Foods to be delivered to the dressing room.

- 2. Merchandise will require two 6 ft. tables and 4 chairs are to be set up in designated sales spot.
- 3. Merchandise will be sold one hour prior to, during, and after the performance.
