TERMS & CONDITIONS

This Agreement is hereby made between Rosales Roofing LLC., (herein referred to as the "Company") and the customer named in the proposal (hereinafter referred to as the "Client"), jointly "Parties" and shall be validated upon the signing of the attached proposal ("Proposal"), which includes an itemized list of tasks to be performed at the location specified in the Proposal. This Agreement becomes effective as of the date the Proposal is signed.

1. Statement of Intent. Subject to the terms and conditions of this Agreement, the Client engages the Company to perform certain home improvement and/or construction services as set forth below, at the location named in the attached proposal ("Location"), and the Company hereby accepts such engagement.
2. Effective Date. The terms of this Agreement are effective as of the date of its execution by the Parties.
3. Scope of Work. The Company shall submit a proposal itemizing the tasks to be performed at the "Location". The final proposal ("Proposal"), as agreed to and signed by the Parties, shall detail any and all tasks ("Agreed Tasks") to be completed by the Company as outlined in the attached proposal. This Agreement is limited to the tasks detailed in the attached Proposal. Any additional tasks the Client wishes to engage the Company to perform would be subject to a new Agreement between the Parties.
4. Client's Duties. Client shall enable the Company to complete the Agreed Tasks (see Scope of Work) as follows:
 - A. As compensation for materials, labor, permits, and its expertise, Client shall pay the Company the total specified on the Proposal.
 - i. The Client shall pay the first installment ("Down Payment"), upon signing of proposal.
 - ii. Upon completion of the Agreed Tasks, Client shall pay the remaining balance ("Final Payment"), upon completion. If Final Payment has not been received within fourteen days, the Company will place a lien on the house and send the balance to collections.
 - B. If more materials are needed to complete the Agreed Tasks, the Client will reimburse the Company, and this amount will be added to the invoice.
 - C. When working with and around powered roof fans (such as ventilation or exhaust fans), Client shall provide their own electrician. In the event that the Client can't/does not wish to do so, Client agrees to pay the hourly rate of an electrician hired by the Company.
 - D. For Agreed Tasks in interior locations, Client shall move any and all workspace obstructions (such as furniture, curtains, and/or related fixtures) prior to the commencement of work. In the event the Company has to move such obstructions to access the workspace, the Client agrees to compensate the Company at a rate of \$100/per hour.
 - E. When making payments to the Company, Client agrees to pay these additional payment- related fees in the following circumstances:
 - i. Payment by credit card: 3.5% of the amount paid.
 - ii. Nonsufficient funds/ "bounced" check: \$100.00 per check.
 - iii. Late payment: 2% of the past-due amount after 30 days.
 - F. Client shall identify one entrance to the Location. During work, Client shall limit travel to and from the Location to said entrance. This is to ensure Client's safety on the worksite.
5. Start of Work. Work shall tentatively commence 4 weeks after the signing of the proposal unless otherwise agreed

upon, subject to the following:

- A. The Company must have received the Down Payment (see 4A above).
- B. The Company must have received the Down Payment in enough time to acquire the work materials and permits.

Start of Work will be delayed until such time as the above conditions have been met, subject to Company availability and pricing.

6. Company's Duties. The Company shall complete all of the Agreed Tasks in a workmanlike fashion and in compliance with all building codes and other applicable laws.

- A. Upon receiving the Down Payment, the Company shall acquire all permits and necessary materials for the completion of the Agreed Tasks.
- B. Company may, at its discretion, employ subcontractors and other employees to perform the Agreed Tasks. Company is responsible for payment and liability considerations for such parties.
- C. Company warrants that it is adequately insured for injury to its employees and other loss or injury incurred as a result of the Company, its employees, or subcontractors.
- D. The Company will use best efforts to protect the Location from damage. The Company shall not be held liable for any damage to the interior (for example, "nail pops" or vibrations knocking pictures off the wall).
- E. Upon completion of the Agreed Tasks, Company shall use best efforts to remove all debris and leave the Location in a 'clean' condition. The Company cannot guarantee removal of all nails from grass at the location.
- F. The Company shall not be liable for any delay due to circumstances beyond its control, including (but not limited to) strikes, casualty, or general unavailability of materials.

7. Limited Warranty. In the event that any work performed by the Company requires repair or replacement within five years (from the date of completion), the Company shall repair or replace the said work at its own expense. This warranty extends only to problems resulting from labor performed by the Company, not due to normal wear and tear, faulty materials, misuse of Location by Client, or act of God.

8. Entire Understanding. This Agreement and any attachments hereto constitute the entire understanding and agreement of the parties. Any prior agreements, understandings, and representations are hereby terminated and canceled in their entirety and are no longer in force and effect.

9. Amendment. No amendment, change, or modification of this Agreement shall be valid unless in writing and signed by the parties hereto.

10. Choice of Law. This Agreement shall be governed by the laws of the State of Illinois. The Parties agree that the Fifth Municipal District of the Circuit Court of Cook County, Illinois, is the proper venue for any lawsuit filed in connection with this Agreement.

11. Attorney's Fees. The Client agrees to pay all attorney's fees incurred by enforcement of this Agreement. If it is necessary for the Company to file suit against the Client for collection of any sums due under this Agreement, the Client will be responsible for all court costs, attorney's fees, and interest accrued.

12. Severability. If any provision of this Agreement, or any portion thereof, is held to be invalid or unenforceable, the remainder of this Agreement shall nevertheless remain in full force and effect.
