Aquatic Weed and Aerator Maintenance - ITB 22-060 Bid Award

History

On November 21, 2022, ITB 22-060 "Aquatic Weed and Aerator Maintenance 2023-2025" was issued by the Public Works Department. The ITB requested proposals from interested parties for aquatic weed and aerator maintenance at Village stormwater basins (Scheduled Basins), as well as the maintenance and winter storage of Village-owned aerators. There are currently thirty-seven (37) "Scheduled Basins" and five (5) aerators that require regular maintenance. The contract with the Village's previous aquatic weed contractor, Clark Aquatic, concludes at the end of 2022. The ITB also requested pricing for 2026 & 2027, so the Village has the option to extend the

contract for an additional two (2) years

The ITB was opened on December 7, 2022, with two (2) companies submitting proposals. The ITB report and bid tabulation are attached for reference. The ITB stated that the proposer shall provide an annual fixed cost per year for the inspection and treatment of Scheduled Basins, as well as aerator maintenance/winterization. The proposed per year totals were as follows:

McCloud Aquatics

2023 - \$52,474.50 per year

2024 - \$52,474.50 per year

2025 - \$54,418.00 per year

Prices if contract is extended

2026 - \$54,418.00 per year

2027 - \$55,195.40 per year

Solitude Lake Management, LLC

2023 - \$113,836.00 per year

2024 - \$117,251.08 per year

2025 - \$120,795.54 per year

Prices If contract is extended

2026 - \$124,386.49 per year

2027 - \$128,109.47 per year

The lowest qualified bidder was McCloud Aquatics, of Elburn, IL. Staff contacted the three (3) references listed on McCloud Aquatics submittal. All references that were contacted had high praise for McCloud's services, and credited the company with a strong quality of work and professionalism. As such, staff recommends awarding ITB 22-060 "Aquatic Weed and Aerator Maintenance 2023-2025" with the option to extend to 2026 and 2027 to McCloud Aquatics.

Financial Impact

Funds for this project are available in account 5008170-442210, pending the FY23 budget approval.

Recommended Action/Motion

I move to approve awarding ITB 22-060 "Aquatic Weed and Aerator Maintenance 2023 - 2025," with the option to extend the contract two (2) additional years, in an amount not to exceed the annual budgeted amount for aquatic weed control to McCloud Aquatic of Elburn, IL;

AND

Authorize the Village Manager to execute all related contracts, subject to Village
