# 2013-0034 Amendment to Title 9, Chapter 14, Section 1 of the Orland Park Village Code (Illinois Vehicle Code Sections Adopted) - Recommended Ordinance

Chief McCarthy reported that on July 20, 2012, PA 96-130 was amended making it unlawful to use an electronic communication device for sending texts, emails or other electronic messages while driving. (625 ILCS 5/12-610.2) It has been widely recognized that texting or emailing while driving is dangerous and the cause of many serious accidents.

We are requesting to amend Title 9, Chapter 14, Section 1 to add this State Statute to our existing list of equipment violations so that the citation may be issued under our administrative adjudication system for parking and equipment violations.

I move to recommend to the Village Board to pass an Ordinance entitled: AN ORDINANCE AMENDING TITLE 9, CHAPTER 14, SECTION 1 OF THE ORLAND PARK VILLAGE CODE (ILLINOIS VEHICLE CODE SECTIONS ADOPTED)

#### 2013-0024 Annual Purchase of Ammunition - Purchase

Chief McCarthy reported that the Police Department annually purchases ammunition through the State of Illinois Purchasing Contract. Our two largest purchases are for .40 caliber ammunition for our pistols and 5.56 mm ammunition for our patrol rifle carbines.

To avoid a dramatic price increase as the result of increased military and civilian purchases that go into effect on February 6th; we are requesting to purchase our ammunition as soon as possible while supplies last.

I move to recommend to the Village Board to approve the purchase of ammunition from Ray O'Herron Co. off the State of Illinois Purchasing Contract for 21 cases of Winchester 180 gr., .40 caliber ammunition and 17 cases of Winchester 55 gr., 5.56mm ammunition at a price not to exceed \$9,933.00
