AN ORDINANCE AMENDING TITLE 6, CHAPTER 1 (HEALTH CODE) OF THE VILLAGE OF ORLAND PARK, AS AMENDED ADOPTING THE FOOD SERVICE SANITATION CODE OF 2025 AND THE 2022 FDA FOOD CODE

WHEREAS, the Corporate Authorities of the Village of Orland Park (Village), an Illinois home rule municipality, desire to adopt the 2025 Food Service Sanitation Code published by the Illinois Department of Public Health, as well as the chapters of the 2022 Food and Drug Agency (FDA) Food Code as referenced and incorporated in the 2025 Food Service Sanitation Code, for the control of health and sanitation as provided therein; and

WHEREAS, amendments to the Food Service Sanitation Code are published from time to time, and the Village reviews and adopts such updated Code provisions as necessary and required to keep the Village Code up to date and in line with adopted state standards; and

WHEREAS, the Village further has engaged in a process to solicit input and keep the food service community informed about the adoption of such updates; and

WHEREAS, the President and Board of Trustees have considered the adoption of the Food Service Sanitation Code and the FDA Food Code, including the local amendments proposed thereto; have offered input; and have determined them to be in the best interests of the Village and its residents;

NOW, THEREFORE, Be It Ordained by the President and Board of Trustees of the Village of Orland Park, Cook and Will Counties, Illinois, as follows:

SECTION 1: This Board finds and determines that the adoption of the following amendments to Title 6, Chapter 1 of the Village Code of the Village of Orland Park is in the best interests of the Village and its residents, and is in the public interest.

SECTION 2: Title 6, Chapter 1 of the Village Code of the Village of Orland Park is hereby amended by adopting the changes as reflected on the attached Exhibit A, “2025 Adoption of Food Service Sanitation Code and Proposed Amendment to Title 6, Chapter 1” by deleting the text marked with strikethrough and adding the text marked in underline.

SECTION 3: To the extent necessary, all tables of contents, indexes, headings, and internal references or cross-references to Sections that need to be amended or deleted within the Orland Park Village Code, as amended, as a consequence of the above Code Amendments, shall be amended by the Village’s codifier so as to be consistent with the terms of this Ordinance.

SECTION 4: All ordinances, or parts of ordinances, in conflict with the provisions of this Ordinance, to the extent of such conflict, are repealed.

SECTION 5: Each section, paragraph, clause and provision of this Ordinance is separable and if any provision is held unconstitutional or invalid for any reason, such decision shall not affect the remainder of this Ordinance, nor any part thereof, other than that part affected by such decision.

SECTION 6: Except as to the Code amendments set forth above in this Ordinance, all Chapters and Sections of the Orland Park Village Code, as amended, shall remain in full force and effect.

SECTION 7: This Ordinance shall be in full force and effect from and after its adoption and publication in pamphlet form as provided by law.

SECTION 8: The Village Clerk be and herby is authorized and directed to publish this Ordinance in pamphlet form.
