**ADDENDUM A TO EMPLOYEE LEASING AGREEMENT, DATED JUNE 29, 2023,
BETWEEN
THE VILLAGE OF ORLAND PARK AND GOVTEMPSUSA, LLC**

WHEREAS, on June 29, 2023, a certain Agreement between the VILLAGE OF ORLAND PARK (hereinafter referred to as "Village") and GOVTEMPSUSA, LLC (hereinafter referred to as "Consultant") for the performance of Interim Finance Manager for the Village in connection with the Finance Department (hereinafter referred to as the "Project", the "Work", or the "Services") was executed (hereinafter referred to as the "Agreement"); and,

WHEREAS, the Village wishes to modify **THE EMPLOYEE LEASING AGREEMENT**.

NOW, THEREFORE, for and in consideration of the foregoing and the mutual covenants herein contained, it is agreed by and between the parties hereto as follows:

1. In the event of any conflict or inconsistency between the provisions of this Addendum A and the Agreement, the provisions of this Addendum A shall control.
2. **THE EMPLOYEE LEASING AGREEMENT** shall be amended to include Addendum A, dated December 5, 2023; and Exhibit A, dated November 28, 2023; to strike the Consultant's Name "GOVTEMPSUSA, LLC," and replace with MGT of America Consulting, LLC" hereinafter referred to collectively as the "CONSULTANT".
3. All of the other terms, covenants, representations and conditions of said Agreement not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.
4. This Addendum A may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.


